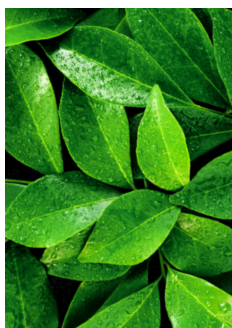

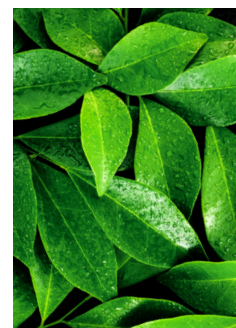

CellMate is a liquid nutrient designed for foliar applications to provide calcium and other nutrient that may be deficient in the soil or plant.

DIRECTIONS FOR USE

Avoid spraying in the heat of the day or when the plant is under moisture stress to achieve optimal product performance. **DO NOT** spray to the point of runoff. Recommended mixing sequence: water, adjuvants, pesticides, Valent BioSciences nutrient products, other fertilizers, balance of water while agitating. When mixing with high phosphate fertilizers, add a citric acid buffer until the pH is 4.5 to 5.0 to improve compatibility and uptake. A standard jar test is recommended before tank mixing.

RATES & TIMING FOR ALL CROPS

Apply **2.5-10 L/ha** anytime during the growing season.

WARNING: Excessive use of molybdenum (Mo) can be harmful to stock. Plant levels of Mo can be high for 4 weeks after application. It is advisable to keep stock off treated areas for this period. Molybdenum application may induce copper deficiency in grazing animals. This is most likely to occur on sandy soils low in copper. Check rate and frequency of molybdenum use with appropriate authorities.
